The Village Emergency Operations Team is working hard to ensure the health and well-being of the community. As we continue to monitor the latest information on COVID-19 (Coronavirus), updated information will be shared with the community.

Social Distancing In Bal Harbour

The Bal Harbour Beach Walking Path and Collins Avenue sidewalks are incredible community assets, even more so with the April sunny weather. It is important to keep in mind under our "[Safer At Home](#)" order, that while we are enjoying these assets, that we practice appropriate social distancing. First and foremost stay at home as much as possible. When you are enjoying the outside, keep at least a 6 feet distance from others in all public areas, avoid public (and private) gatherings with people outside your household, all while remaining courteous and friendly to your neighbors from a safe distance.

Recent County Emergency Order

On March 31, 2020, Miami-Dade County Mayor Carlos Gimenez issued [Executive Order 15-20](#) closing, for all purposes, all commercial and non-commercial pools, hot tubs, golf courses, tennis courts, basketball courts, fitness centers, gymnasiums, and other common use amenities, in Miami-Dade County, excepting those facilities on single-family, townhouse, duplex or villa residential lots. Emergency Order Update #7

On March 30, 2020, the Village Manager issued **Update #7** to the emergency restrictions issued on March 16, 2020, requiring **all persons arriving in Bal Harbour Village** by any means from CDC identified and international locations, to **isolate or quarantine for 14-days**. Miami-Dade County COVID-19 Drive-Through

Miami-Dade County COVID-19 drive-through testing center is now open at Marlins Park for residents **18 or older** from 9:00 a.m. to 5:00 p.m. **by appointment only**. Daily testing is available at this site for 300 people. To make a testing appointment, please call 305.499.8767, where individuals will be pre-screened for symptoms. Staff on-site can only test those with appointments. All others will be turned away.

Miami-Dade County COVID-19 Drive-Through

Miami-Dade County COVID-19 drive-through testing is now available from 9:00 a.m. – 5:00 p.m. on a daily basis; however, those seeking a test must meet certain criteria:

- Must be 65 or older and be symptomatic to be tested (Must bring ID)
- If you do not meet the criteria, you will be asked to exit the lot.
- The test site is drive-through only.
- Test results will take 48-72 hours.

New Testing Sites

(Municipal Parking Lot adjacent to the Eden Roc Hotel)

Drive-through testing began today, Thursday, April 2, 2020, and will take place daily from 10:00 a.m. until 6:00 p.m. to members of the general public of any age who have been pre-approved by a doctor, and have symptoms of COVID-19, or have been in contact with someone who has tested positive. Privately owned Medrite Urgent Care will provide 250-300 test per day. Anyone interested can call 305-735-3909 for an appointment or for more information about testing.

Miami-Dade County COVID-19 Drive-Through

Miami-Dade County COVID-19 drive-through testing is now available for those who are 65 or older and are experiencing symptoms. Appointments are required and patients need to be in their cars, with a maximum of two people per car. The call center will open each day at 9 a.m. and close when slots for the next day are filled. The number to call for appointments at this site is 305-268-4319 – that's 305-COVID19.

Recent State & County Emergency Orders

State Orders

- April 1, 2020: Florida Governor Ron Desantis issued Executive Order 20-91 regarding a "Safer at Home" provision, which is similar to Miami-Dade County's Emergency Order #10-20. The Village is reviewing the Governor's order to determine any additional impacts to the Village.
- March 30, 2020: Governor DeSantis issued Executive Order 20-89 directing Miami-Dade, Broward, Palm Beach and Monroe Counties to restrict public access to businesses and facilities deemed non-essential pursuant to [Miami-Dade Emergency Order 07-20](#). - March 23, 2020: **Governor DeSantis issued Executive Order 20-80** directing all individuals arriving in the State of Florida from an area with substantial community spread, including the New York Tri-State Area (Connecticut, New Jersey and New York), to isolate or quarantine for a period of 14 days from the time of entry into the state or the duration of the person's presence in the state, whichever is shorter. County Orders

- March 24, 2020: **County Mayor Gimenez issued Miami-Dade Order #10-20, urging individuals to remain home other than to engage in essential activities which include, travel to or from essential retail and commercial businesses.** This order is similar to the order issued yesterday by Bal Harbour Village. Information from the Florida Department of Health

If you think you have been exposed to COVID-19 and develop a fever and symptoms, such as cough or difficulty breathing, the Florida Department of Health (DOH) recommends the following in order to be tested:

- Call the DOH Epidemiology Department at (305) 470-5660 for guidance, or
- Contact your primary care physician, explain your symptoms and whether or not you have been in contact with someone who has tested positive for COVID-19 over the past 14 days, or
- Contact an urgent care facility or hospital emergency room, explain your symptoms and whether or not you have been in contact with someone who has tested positive for COVID-19 over the past 14 days.
