Summary of Activities and Events

Code Enforcement

Code Enforcement Officers (CEOs) continue their assistance to the Building Department in ensuring construction sites operate within code standards. CEOs issued a warning and a violation to a construction site on the 100 Block of Camden Drive for not adhering to code. The site was issued a warning for not properly covering its portable bathroom station and a violation for failing to properly maintain its dumpster. Code Officers have previously warned construction personnel about properly maintaining the site.

A construction site on the 100 Block of Bal Cross Drive was issued a warning for not properly covering the dumpster. CEOs reminded the construction crew of the Village code requiring dumpsters to be property maintained.

Code Officers patrolling the area of Park Drive noticed a residence with roof damage. A tarp covered the damage portioned of the roof but had become loose and unsightly. CEOs issued the property owner a code warning requesting the tarp be repaired or replaced.

CEOs patrolling the area of Camden Drive discovered a vehicle parked on a residential lawn. Parking on the lawn is prohibited by Village code and the homeowner was issued a warning and a copy of the applicable code.

The Code Enforcement Unit received a complaint of debris on the beach behind a hotel. Hotel management was informed of the complaint and reminded to police its beach areas for debris. The hotel staff was fully cooperative and will ensure the area is inspected on a daily basis.

Criminal Investigations

Detectives participated in a conference call with the Miami-Dade State Attorney's Office regarding an anti-Semitic incident that occurred late May. Although there were insufficient grounds to proceed with a prosecution, the incident remains documented and was shared with other state and federal agencies for future reference.

The Criminal Investigations Division (CID) concluded an investigation in an alleged burglary in the residential area. The investigation revealed the incident was not a burglary but was related to a landlord-tenant dispute and an eviction. The case was reclassified to a civil matter since it did not meet the elements of a criminal act.

The CID concluded an investigation into an alleged robbery that occurred at a beachside hotel. The investigation revealed the incident was a domestic related disturbance and no property was actually stolen. The couple involved in the case reside in the state of Michigan. The case was unfounded as a robbery and reclassified to a disturbance.

Detectives are investigating an allegation of fraud made by a beachside condominium. The building management team received an email requesting payment \$28,000 for vendor services be made to a Green-Dot account. They later discovered someone spoofed the vendor's email account to divert the funds to the Green-Dot account. Green-Dot accounts are usually anonymous, refillable, credit-card like services that can be funded as if it were a bank account. These accounts are often used by scammers to hide their money trail.

Remarks

Marine Patrol:

Bal Harbour marine patrol officers assisted Miami-Dade Police marine patrol in rescuing a stranded Kayaker who was battling strong currents in the intercoastal waterways.

The Bal Harbour marine patrol vessel was down for maintenance and minor repairs from June 9 through June 16, 2021.

Beach Safety Detail:

Beach attendance was low this week due to weather conditions.

The BSO encountered three dogs on the beach, the owners were issued a verbal warning and immediately removed the dogs.

Summary of Noteworthy Calls for Service

06-11-2021 Assist Other Agency Broad Causeway Bridge

Bal Harbour officers assisted Bay Harbor Islands with traffic control. Miami-Dade air rescue landed along SR 922 in order to transport a boating accident victim to the hospital. Bal Harbour officers remained on scene until roadways were reopened.

06-12-2021 Traffic Incident 10200 b lk Collins Avenue

While patrolling the Collins Avenue corridor, Bal Harbour officers received a stole tag alert from the LPR system. Officers located the vehicle and conducted a traffic stop. The traffic investigation confirmed the tag was stolen. The tag was impounded and the driver was issued multiple citations.

06-14-2021 Theft 9700 Collins Avenue

Employees at the Gucci store summoned Bal Harbour police regarding a theft. According to the employees, two individuals entered the store and removed several items from the display and left without paying. The video footage capturing the theft was requested to be persevered. The Criminal Investigations Division will conduct a follow-up investigation.

06-15-2021 Stolen License Plate 10200 Collins Avenue

Bal Harbour officers received a stolen vehicle alert from the LPR system. Officers located the vehicle and initiated a traffic stop. The investigation revealed at some point, the assigned license plate was swapped with a license plate that was previously reported as a stolen vehicle. The stolen license plate was impounded and the occupants were released on scene.
