- 3) Hold Harmless agreement attached hereto must be executed by an authorized agent of the financially responsible party.

**PROCESSING OF APPLICATION CAN NOT BE GUARANTEED UNTIL ALL THE NECESSARY REQUIREMENTS AND DOCUMENTATION HAVE BEEN COMPLETED AND SUBMITTED IN THEIR ENTIRETY AT LEAST ONE (1) WEEK PRIOR TO USE OF PERMIT.**
