- Alejandro Levy, having received a majority of the votes in the November 5, 2024 General Municipal Election for the councilmember for Council District 4, is hereby declared to be elected.

This election is in accordance with Section 14 of the Village Charter, Ordinance 2010-545 by express authority of Florida Statutes Sections 100.3605(2) and 200.021, and Section 8 of the Bal Harbour Village Code.

#### ADMINISTRATIVE RECOMMENDATION

Ratification of Bal Harbour Village General Municipal Election - Ministerial Action.

#### **BACKGROUND**

Section 212.0306, Florida Statues, authorizes any county to impose a one-percent tax on food, beverages, and alcoholic beverages on establishments (excepting hotels and motels) with gross annual revenues in a previous calendar year of \$400,000. Proceeds from this tax are used to address homeless needs and are administered by the Homeless Trust, which oversees implementation of the Miami-Dade County Community Homeless Plan. Proceeds are also used to address the needs of domestic violence victims.

Historically, the Village of Bal Harbour (and the municipalities of Miami Beach and Surfside) has been exempt from Section 212.0306 in that it had already imposed a municipal resort tax authorized by Chapter 67-930, Laws of Florida.

In 2023 the Florida Legislature, amended the statute to allow exempt municipalities authorize the county in which they are located to levy the one-percent tax after first adopting an ordinance that is subsequently approved at a local referendum held at a general election.

On December 18, 2023, the Bal Harbour Village Council passed Ordinance 2023-655 adopting the homeless and domestic violence tax pursuant to Section 212.0306(2)(d). which allowed the Council to submit a referendum question to the electors of the Village on whether to authorize Miami-Dade County to levy a one-percent tax on qualified establishments at the next general election scheduled for November 5, 2024.

WHEREAS, the Village Council has deliberated and considered that the Village is currently in active litigation, and therefore concluded that it is in the best interests of the Village to keep Mayor Jeffrey Freimark and Vice Mayor Seth Salver in their positions for one more year from November 2024 through November 2025; and

**WHEREAS**, the Village Council has further deliberated regarding the following year prior to the November 2026 Village election and made their selections for Mayor and Vice Mayor for November 2025 through November 2026.

# NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF BAL HARBOUR VILLAGE, FLORIDA, AS FOLLOWS:

**Section 1.** Recitals Adopted. That the above stated recitals are hereby adopted and confirmed.

<u>Section 2.</u> <u>Mayor and Vice Mayor Elected for 2024-25.</u> That Jeffrey Freimark is hereby elected to continue as Mayor of Bal Harbour Village, and Seth Salver is hereby elected to continue as Vice Mayor of Bal Harbour Village, for November 2024 through November 2025.

<u>Section 3</u>. <u>Mayor and Vice Mayor Elected for 2025-26</u>. That Seth Salver is hereby elected Mayor of Bal Harbour Village, and David Wolf is hereby elected Vice Mayor of Bal Harbour Village, for November 2025 through November 2026.

<u>Section 4</u>. <u>Effective Date</u>. That this Resolution shall take effect immediately upon the adoption hereof.
